EDG2116 Truro & Roseland CNP TRO 2022

Cormac Solutions Ltd, on behalf of Cornwall Council are inviting comments on proposals to implement or amend restrictions on waiting and speed at various locations within Truro and Roseland. These changes have been nominated by town/parish councils and local members throughout the Truro and Roseland Community Network area.

Details of the schemes are as follows:

Various Roads, Tregony

Proposed no waiting at any time (double yellow line) restrictions to prevent obstructive and inconsiderate parking close to junctions and on bends whilst allowing parking where it is safe adjacent to the church hall and village hall. No waiting is proposed adjacent to the school in order to control parking during opening and closing times. Refer to site notices EDG2116_SN01 and EDG2116_SN02 for details.

Carvedras Court

Proposed no waiting at any time (double yellow line) restrictions along its length to prevent inconsiderate parking by non-resident vehicles. Refer to site notice EDG2116_SN03 for details.

Malpas Road (Sunny Corner), Truro

Proposed replacement of existing no waiting (single yellow line) restrictions with no waiting at any time (double yellow line) restrictions to prevent parking at any time in the vicinity of the tight bend in the road. Refer to site notice EDG2116_SN04 for details.



Pepo Lane and New Hill Estate, Grampond

Proposed no waiting at any time (double yellow line) restrictions to prevent parking in the vicinity of the junction at any time. Refer to site notice EDG2116_SN05 for details.

Wheal Jane Meadows, Threemilestone

Proposed no waiting at any time (double yellow line) restrictions at its junction with Chyvelah Road to prevent parking in the vicinity of this junction. Refer to site notice EDG2116_SN06 for details.

The Square and The Luggar, Portscatho

Proposed alteration of existing limited waiting bays to remove seasonal element and extend restrictive hours with the aim of ensuring parking is controlled all year round and throughout the entire working day. Refer to site notice EDG2116_SN07 for details.

Navigator Way, Scholar Road, Penwethers Crescent, Truro

Proposed no waiting at any time (double yellow line) restrictions to prevent inappropriate parking on or in the vicinity of junctions and tight bends. Refer to site notice EDG2116_SN08 for details.

Chyvelah Road, Threemilestone

Proposed alteration of existing limited waiting parking bay to reduce length by 5m (one car parking space) in order to accommodate planned road improvement works and pedestrian crossing. Refer to site notice EDG2116_SN09 for details.

Ruan High Lanes

Proposed extension of existing 40mph speed limit in order to encourage reduced vehicle speeds and improve road safety and amenity. Refer to site notice EDG2116_SN10 for details.
