MINUTES OF THE ANNUAL PARISH MEETING - MATTERS ARISING

1. Churchtown Road - access, parking and speeding

KG referred to minutes of previous meetings when these matters had been discussed, and to the last speed survey carried out in 2018. She volunteered to produce a list of issues raised, and potential ideas suggested to date, for a new Traffic Regulation Order for the Parish, for which there might be the possibility of access to funds from the Community Network panel. This would be a starting point for development of practical policy. Members were also reminded of a Zoom meeting organised by the "20's Plenty" campaign to be held on June 29th, and agreed to discuss the matter further at the July meeting.

2. Affordable Housing

Members agreed that there is a need for considerably more current accurate data on matters such as:

- what is the local housing need
- who is actually occupying the social housing available locally
- what sites might be available/suitable locally for new-builds
- who might actually carry out any building works.

It was further agreed that there needed to be a responsible Councillor or Working Group for this issue. HH,JC and JH volunteered to begin the necessary research and consultations, and to report back at the July meeting.

APPENDIX 1

Report from Ward Member CC Julian German

My apologies for the PC meeting this month, which clashes with the Truro and Roseland Community Network Panel (CNP). Given the reminder on meeting times, I thought I would send a report to yourselves and attend the virtual meeting.

In terms of Churchtown Road being on the agenda I have attached the last speed visor report for this road. These are valid for three years but I have asked highways to carry out another one closer to the Parc an Dillon junction. I expect you are aware of the 20 is plenty campaign, and the PC may want to consider this. My expectation is that there will be a Traffic Road Order available through the CNP.

Please let me know if I can assist following the housing discussion.

I have reported damage at the front of the jetty and damage to the path at the rear.

I am awaiting further information about Tall Ships and will call a meeting about this, hopefully, soon.

I understand the White Stone has been struck since its repositioning and the new paving edges being installed. I hope to have the highways steward out in the next fortnight, so please let me know if there are any highways issues you want me to raise.

Following on from my last report, some further Cornwall Council information, this time focussing on Cormac:

CC responsible for 4,500miles of roads, 2,600miles of public rights of ways with footpath maintenance predominantly carried out by Parish and Town Councils, 1,500 bridges and 1,200 retaining walls.

106 volunteer groups work with Cormac on litter picking, In Bloom and other environmental initiatives.

In rural areas there is a six- monthly inspection of the highway. A category 1 defect (for example, a pot hole which is over four cms deep) should be fixed in 72hours. Currently this measure is at 99% met. Given that highway inspections are six monthly, it may take a long time for something to be noticed by highways so please use report something on the councils website Report something - Cornwall Council This has a wide range of things that can be reported, from food safety to dog fouling, fro This has a wide range of things that can be reported, from food safety to dog fouling, from dead animals on the highway for removal to blocked drains, please use it.
