# **PAVEMENT ACCESS**

Councillors discussed the possibility of installing a dropped kerb to the pavement on The Lugger to allow access for wheelchairs, pushchairs and mobility scooters. Cornwall Highways Manager had advised this would be possible without a Traffic Regulation Order. The Clerk advised that such a project would be an appropriate use of CIL money. Councillors agreed to seek quotes for dropping the kerb around the corner to the slipway so that the issue of 'hanging up' might also be addressed.

# Report from the Clark (Agenda item 6)

I can report the following matters dealt with arising from minutes of the last few meetings, or otherwise of relevance. All decisions were taken in consultation with the Chair, and in line with governance.

# 1. At New Road car park:

- (a) the new arrangement with a subcontractor collecting and banking the pay and display machine takings is working smoothly now that we have sorted out the necessary banking admin.
- (b) a quote of £450 from our usual contractor to repair the latest vehicle damage to the Cornish hedge has been accepted.
- (c) our footpaths maintenance contractor has cleared a strip on NT land below the Eastern boundary Cornish hedge to afford us access to maintain our drains.
- 2. Our contractor has also strimmed back overgrowth along the length of Eshcol Lane.
- 3. The noticeboard at Trewithian has been cleared of overgrown brambles.
- **4**. A complaint from the site supervisor for Gerrans Primary schools regarding ivy in our playground overwhelming their fence has been addressed and resolved.

- **5.** A reported fallen tree blocking a footpath at Polingey has been removed.
- **6.** Blockages at Percuil toilets occurring during the bank holiday/regatta weekend were commercially jetted and a camera investigation was ordered because of other recent blockages. The investigation revealed tree root ingress, and work to clear this has been requested at a basic cost of £185.00.
- **7.** The new replacement defibrillator for Gerrans, funded by the PC, has now been delivered and installed. A letter of thanks from the Roseland Surgeries Patients Group has been received and circulated amongst members.
- **8.** The new operators of the beach cafe at Tatams have informed us that they intend to close the outlet during the winter months, while carrying on the trade from within their other site underneath the Harbour Club. This will not affect the operation of the public toilets.

# Report from the Community Area Partnership (Agenda Item 10)

LW attended the Climate sub-group from CAP.

CC is doing review on local energy.

Local Energy Partnership/Action Plan: Cornwall covers the energy system for Cornwall and is looking at the full energy system. Data is being gathered with intention to develop an Action Plan. There will be work with PC's and businesses across the country to develop the plan by Mid 2024.

There is information and a survey available online: see Cornwall and Isles of Scilly Local Area Energy Plan /Let's Talk Cornwall

A residents' panel (circa 50 residents) to gather additional viewpoints will be formed

Mid- Cornwall Eco Hub; open from 30th Sept in response to get more info out to people and ideas across groups. There is physical space for the public to come to as well as groups within the environmental sector. It is to help understand more about the climate crisis and what you can do about it.

Tregony PC is doing a lot of eco projects: sustainable transport etc On the CC website there's also a sustainability guide. REACT also want to get more heads together
